



# **Conservation District Nursery Plants**

This is the second in our series of plants that will be established at the Coös County Conservation District Nursery.

Agastache foeniculum - meaning: a much branching, ear-of-grain like flower, with an aromatic (fennel scented) aroma.

This popular perennial plant in the Mint Family has a number of distinctive Common names: Anise hyssop, Blue Giant Hyssop, even Wonder Honey Plant. The latter name

especially earns it a place in our nursery, as it recognizes its potential as a nectar source for bees, hummingbirds and butterflies. In more sedate Victorian times, when bee-keeping on a national scale was less mobile, efforts to find the best bee-keeping plant was a goal. There was a high regard for this plant:

"It (Agastache foeniculum), Wonder Honey Plant, produces honey in the greatest abundance, which possess in a slight degree the same fragrance as the plant, which renders it exceedingly pleasant to the taste... I firmly believe that an acre of this plant well established would be ample pasturage for 100 colonies of bees" Beekeeper's Journal 1872"

Of high sugar concentration, Agastache is said to produce light in color, full-bodied honey with a delicate minty flavor. Important to apiculturist is the - timing - of bloom. That so their hives have a reliable source of nectar after the abundance of pollen and nectar following dandelions and clovers. Flowering from June into early Autumn, this plant helps them get past the dry summer nectar drought. That is probably one of the reasons it also rates so high as a native bee/pollinator plant. Being somewhat deer-resistant is an added benefit.

Although they grow fairly readily from seed, we will be using mostly one-year old plants, many started for us by a local green-house grower. Their vigorous stolons (typical of the mints) should quickly spread into tall clumps which can be divided for transplanting in Spring and Fall. We will be establishing them in moist, fairly sunny woodland edges for best effect. The picture shows one particularly attractive purple-blue flowered clump in front of red Bee-Balm, another good pollinator plant.
